

Property Development Pathways

We are pleased to announce a new set of guidance on how to undertake a property project on Methodist properties called the [Property Development Pathways](#). The aim of this guidance is to improve communication and better publicise resources that are available for managing trustees.



Within the [Property Development Pathways](#), there is a **core path** that has a common set of steps to follow for every project. These core aspects should be followed in order to achieve success - both for the mission and for the development of the property. The guidance can also be scaled up or scaled down depending on the size of the project. [Click here to view a summary of the 8 core steps.](#)

The information and guidance is available for managing trustees to use as dictated by any additional parameters of the project. The pathways are designed to be worked through methodically and have been divided into bitesize steps. Thus, it is recommended to begin with Step 1 of the core pathway followed by Step 1 of a supplementary pathway if applicable.

Removal of War Memorials from Closed Churches

Often when our church closes and no longer meets for worship, our thoughts turn to what to do about war memorials and plaques that may adorn our church walls. Indeed, the [Conservation Office](#) receives a number of enquiries and is always keen to help find the most sensitive and appropriate solution. However, we believe that a war memorial should be preserved in its original location as its



relocation can be a high risk, as well as an expensive, project. For guidance on this extremely emotive issue please refer to the [War Memorials Trust's Guidance note on Relocation of War Memorials](#).

A note of reminder for Managing Trustees that the removal of a war memorial or similar fixed object of this nature from a listed church building will always require listed building consent, and that relocation and removal should not be carried out without this. To discuss this, or any matters relating to the removal of objects from a listed building at the point of closure, then [please speak to the Conservation Officer](#).

HSE Updates

Bust the myths on portable appliance testing

Portable appliance testing (PAT) is the examination of electrical appliances and equipment to ensure they are safe to use.

Safe Use of Ladders and Stepladders at Work

HSE has released the latest [annual fatality statistics](#), and there were 29 fatal injuries caused by falling from height in 2021/22.

Ladders and stepladders are not banned under health and safety law. They can be a sensible and practical option for low-risk, short-duration tasks, although they should not automatically be your first choice. To help you make sure you use the right type of ladder, and that you know how to use it safely, [HSE has updated guidance on staying safe when using ladders at work](#). It now includes:

- more detail on competency, and what that means for ladder users and those managing ladder use on site
- key safety advice for using telescopic ladders
- practical tips for using combination and multi-purpose ladders
- good practice for securing ladders

Community Ownership Fund

There is a [Community Ownership Fund](#), which forms part of the Government's Levelling Up Initiative offers funding for those communities who wish to purchase and renovate assets which can then be used for community purposes. It offers funding to cover the purchase, with match funding, and refurbishment of the



asset (including heritage buildings/churches). It has been established to give communities a better ability to compete in the market place. These assets can be designated Assets of Community Value but this is not essential, and it covers the UK.
