Little Changes Make a Big Difference for Barrow upon Soar Methodist Church

In 2012, the Church Council of Barrow upon Soar Methodist Church in Leicestershire discussed their mission in the community and how it could be developed. As the church is over 100 years old, there were access problems with steps, sloping floors, narrow aisles and fixed pews and the heating system was old and the insulation was poor. Places of Worship Protective Security Funding

[The Places of Worship Protective Security Funding Scheme](#) provides funding for places of worship and associated faith community centres that are vulnerable to hate crime. This scheme is intended to reduce:

- the risk of a hate crime happening at a place of worship and associated faith community centre
- the impact of hate crime on the place of worship itself (the building) and people attending the place of worship
- Through the scheme, vulnerable places of worship can apply for protective security measures, such as CCTV, secure fencing, and intruder alarms to be installed at their site for free.



The scheme covers the costs of equipment and installation of all security measures agreed for your place of worship. This includes any maintenance costs for one year from the installation date (such as for CCTV systems or for Monitored Intruder Alarm Systems). You can apply for the installation of up to 3 protective security measures at your place of worship or associated faith community centre. **The application process is open from 19 May 2022 until 14 July 2022.**

TMCP Updates

Streamlining Update

TMCP introduced a new process (Streamlining Process) on 1 September 2021 to reduce the time that is spent on simple property sale transactions where one of the Methodist panel solicitor firms ('the Panel') are instructed by Managing Trustees. Since the introduction of the Streamlining Process we have been listening to feedback from Managing Trustees, the Panel and the TMCP Legal team. As a result of the feedback received, we have made some changes to the [Check-In One Checklist](#) (Checklist) which will result in a slight re-focus of the Check-In One meeting.



Sustaining Historic Churches: What Does Recent Research Tell Us?


Historic Religious Building Alliance have produced a report on [Sustaining Historic Churches: What does recent research tell us?](#)

More research has been carried out on the sustainability of these buildings than any other type of heritage. This is not surprising: the many thousands of listed churches form a substantial proportion of the country's built heritage, yet are cared for by volunteers whose purpose is worship, not heritage, and whose numbers are – on average – shrinking. 
Church Tourism Post Covid

Volunteering: Guidance on how to manage the risks

HSE has guidance on how to manage the risks to volunteers. The guidance explains how [health and safety law applies to volunteering](#) and provides details on [when to report incidents involving volunteers](#).

Reduce the Risks of Electrical injury

Electricity is a part of everyday life, but it can kill or severely injure people and cause damage to property. [HSE's electrical safety at work](#) has advice on how to help reduce the risk of electrical injury. The site also has [helpful resources](#) you can access. There are [simple precautions](#) you can take when working with, or near, electricity to significantly reduce the risk of electrical injury to you and others around you.

Safe Use of Ladders and Stepladders

Falls when working at height remain the most common kind of workplace fatality. Make sure that you use the right type of ladder and that you know how to use it safely. Ladders and stepladders can be a sensible and practical option for low-risk, short-duration tasks, although they should not automatically be your first choice. - where ladders should be used
- inspecting the condition of ladders
