### **Easing of Restrictions**

The government has updated the <u>Guidance for Weddings & Civil Partnerships</u> in England following the Prime Minister's announcement. It states:

From 21 June, there will no longer be a maximum number cap for attendees set out in law. Instead, the number of attendees at weddings, civil partnerships and receptions will be determined by how many people the venue or space can



safely accommodate with social distancing measures in place. This will be based on the COVID-19 risk assessment of the venue or outdoor space, and the measures put in place to limit the spread of COVID-19.

COVID Secure rules, including social distancing requirements, continue to apply in the workplace, and in businesses and public venues. The statutory requirements placed on Landlords of residential property are ever changing. We would like to draw your attention to a recent legislative update which will impact Managing Trustees who let out residential property. In accordance with the <u>Electrical Safety Regulations</u>, landlords must take care to ensure that all electrical installations at the property are inspected and tested at least every five years by a person who is qualified and competent. **This includes both a change of occupancy and current tenants.**

### **Places of Worship Security Funding**

The <u>places of worship (PoW) protective security funding scheme</u> is a government commitment in the 2016-2020 hate crime action plan. This scheme is intended to reduce the risk and impact of hate crime at places of worship and associated faith community centres.

The scheme provides funding for protective security measures, such as CCTV, fencing, and intruder alarms, to places of worship and associated faith community centres that are vulnerable to hate crime. You can submit an application for the installation of up to 3 protective security measures until 2 July 2021. Click here to find out more information.

# Covid-19, Churches & Community Project Report and Findings

The Churches, COVID-19 and Communities
research project was set up to provide detailed
data from a wide range of respondents to



support national and local policy and decision-making in the face of COVID-19 through:

- Examining the impact of closing church buildings and restrictions on activities provided or hosted by churches on the lives and wellbeing of individuals and communities
- Exploring how churches have been able to respond creatively to COVID-19 challenges and adapt to meet new circumstances and needs
- Assessing the potential of church buildings and networks to support recovery and community resilience in the future.
- Identifying the key resources needed to mobilise these assets fully

### **Works on Listed Buildings**

Following notification of works carried out without permission to one of our listed chapels, we wish to offer a brief reminder that all works of alteration (which may include some repairs) to a listed building require listed building approval.

Details of any alteration should therefore be submitted to <u>Joanne Balmforth</u>, <u>Connexional Conservation Officer</u> and approved before the works commence. Failure to do so can be a serious offence and is subject to enforcement action under the relevant Standing Orders. Please also note that the listing covers the whole of the building, not just the exterior.
