

# **Covid-19 Updates**

Although the announcement was made for the roadmap out of lockdown in England, the guidance for churches has not changed because churches have been allowed to remain open during this latest lockdown. Thus, the guidance listed on the

Coronavirus Guidance for Property page is



current until the government makes changes to guidance for the <u>Safe Use of Places of Worship</u> or the <u>Safe Use of Multi-Purpose Facilities</u>.

However, the guidance for <u>Out of School Settings</u> has been updated, which may impact some churches. From 8 March 2021, providers should only offer indoor and outdoor face-to-face provision for:

- Vulnerable children and young people
- Reasonably necessary to enable their parents and carers to work, search
  for work, undertake education or training, or attend a medical appointment
  or address a medical need, or attend a support group
- Being used by electively home educating parents as part of their existing arrangements for their child to receive a suitable full-time education
- Being used as part of their efforts to obtain a regulated qualification, meet the entry requirements for an education institution, or to undertake exams and assessments

Please note this is for England only and please check the websites for <u>Scotland</u>, <u>Wales</u>, <u>Isle of Man</u> and the Channel Islands (<u>Guernsey</u> & <u>Jersey</u>).

## **Methodist Insurance Update**

### **Electrical Wiring**

Church fires can frequently be attributed to faulty or ageing wiring so regular inspections are vital.



Fixed electrical systems should be inspected and tested, at least every five years, by a qualified electrician. There is no statutory frequency for inspection and testing

of portable appliances. Instead the frequency should reflect the risk of the appliance causing damage or injury and this increases with the amount the appliance is used and the harshness of the working environment. Click here to find out more.

## **Asbestos Inspections**

It is a legal requirement that the Managing Trustees have a "duty to manage" any risk from asbestos in church buildings and any other non-domestic premises.



Part of the requirement in managing the risk includes periodically reviewing and monitoring the plan. As well, **the asbestos should be checked regularly**, **between every 6 months to 1 year depending on the type and location**, in order to ensure that the arrangements and the condition of asbestos remain safe. ## **VAT Reclaim for Listed Places of Worship**

The Government has announced that the Listed Places of Worship Grant Scheme will be renewed this year, operating on the same terms as previously. This is the scheme which allows listed places of worship to claim a sum equal to VAT which has been paid on repairs and alterations. The scheme has been extended to March
