
## **Empty Buildings**

If a church building will be empty over the next few weeks, it is important to remember to continue to conduct weekly inspections and run the water in order to prevent legionella. #### **Winter Hints and Tips**

From burst pipes to blocked drains, winter and the cold weather brings with it a range of additional risks and related problems for churches and associated properties. #### **Culture Recovery Funding - Second Round**

The government is offering a <u>Second Round of Cultural Recovery Funding</u>. This offering is for grants from £10k to £3m to support re-opening. The fund is administered by Historic England and the National Lottery Heritage Fund.



Please note that this grant has a very tight timeframe for applications; you can apply from 7 January and applications close on 26 January. We have had some success with the first round of this funding, including one church receiving £78k so please do apply if you feel this is appropriate for your church!

## **Charity Commission Extension**

Methodist charities with gross incomes under £100,000 are 'excepted' from registration with the Charity Commission. The Regulations which provide for this exception were set to end on 31 March 2021. The Charity Commission informed us that the deadline is being extended, which will be a great relief to many local churches. The Legal & Constitutional Practice team have



updated their Charity Registration page on the website with more information.
