- 1. The Authorisations Committee has reviewed applications from Circuits for authorisations to preside at services of Holy Communion where there are insufficient ordained presbyters to make this provision, or where the new missional criterion is met.
- 2. The Committee has, as always, paid careful attention to the details in the applications, and given due consideration to the requests for help. We have declined one application this year on the grounds of not meeting the deprivation figure, although further clarification was sought from some Circuits regarding their submitted nominations.
- 3. The Committee again had the opportunity to consider applications made under the missional criterion approved by the Conference in 2012. We considered four applications made under this criterion, of which two were declined, and we were impressed by the quality of the information provided in support, which helped us immensely in our decision-making. The Committee will be requesting feedback from those projects granted authorisations under missional criteria.
- 4. The Committee considered a total of 75 applications, comprising applications in respect of 40 presbyter probationers, 1 deacon and 34 lay people.
- 5. The 2013 Conference requested further guidance for the Authorisations Committee from the Faith and Order Committee about whether or not deacons should be authorised to preside at the Sacrament of the Lord's Supper. The Faith and Order Committee refers to this in its own report (paragraph 2.14).
- 6. The Committee has agreed with the Queen's Foundation to produce guidance and training material for those who are granted authorisations.
- 7. The process of administration passed to the Governance Support office at Methodist Church House last year and this will continue for the future. Separate revised application forms are now available for authorisation of probationer presbyters, deacons, lay persons, missional applications and renewals. These will be available to District Chairs in October. Applications need to be considered by Circuit Meetings, District Policy Committees and Synods before submission. Subject to the views of the Faith and Order Committee on the principles of applications on behalf of deacons, any applications in respect of deacons will also need to be the subject of comment from the Diaconal Order. All applications for consideration in 2015 should be submitted to Governance Support by Friday 27 March 2015. The Committee will meet at the end of April to consider the applications received.
- 8. Authorisations, when granted, are for one year and their scope is limited to the Circuit in which the person resides. If the district Policy Committee is satisfied that the person authorised remains suitable and the circumstances of the Circuit have not changed, it may on the application of the Circuit Meeting recommend a renewal of the authorisation for a second or third year, and the Authorisations Committee supports any such recommendation without further investigation (see lists B and C below).

- 9. The Committee draws attention to the provisions in SO 011(7) whereby in emergencies arising after the meeting of the Conference by the death of a presbyter or otherwise, the President, or the Vice-President on his or her behalf, may grant an authorisation having immediate effect and continuing until the 31 August following the next meeting of the Conference.
- 10. The Committee welcomes informal consultations with any Circuit considering making an application for an authorisation.
