- 1. The Authorisations Committee has reviewed applications from Circuits for authorisations to preside at services of Holy Communion where there are insufficient ordained presbyters to make this provision, or where the missional criterion is met.
- 2. The Committee has, as always, paid careful attention to the details in the applications, and given due consideration to the requests for help.
- 3. The Committee considered a total of 80 new applications,35 presbyteral probationers, 3 deacons and 42 lay people. 78 authorisations are recommended without further qualification to the 2015 Conference. Two diaconal applications were accepted due to exceptional circumstances. One diaconal application was declined although further clarification was sought regarding their submitted nomination. The Committee has declined to recommend one lay application on the grounds of not meeting the deprivation figure and on the basis that the Circuit should explore further the practice of Extended Communion.
- 4. The Committee again had the opportunity to consider applications made under the missional criterion approved by the 2012 Conference. The Committee considered two applications made under this criterion, and both were approved. The Committee will be requesting feedback from those Circuits granted authorisations under missional criteria.
- 5. Application forms are available for authorisation of probationer presbyters, deacons, lay persons, missional applications and renewals after the three-year term. These will be available to District Chairs in October. Applications need to be considered by Circuit Meetings, District Policy Committees and Synods before submission.
- 6. In the case of rare applications for authorisations for deacons, these should only be submitted following a thorough consultation with the Warden of the Methodist Diaconal Order and on the basis that the Circuit will make every effort to train a lay person to take up the role the following year. Future applications will be subject to the views of the Faith and Order Committee following their report to the 2016 Conference.
- 7. All applications for consideration in 2016 should be submitted to the Conference Office by Friday 25 March 2016. The Committee will meet at the end of April 2016 to consider the applications received.
- 8. Authorisations, when granted, are for one year and their scope is limited to the Circuit in which the person resides. If the District Policy Committee is satisfied that the person authorised remains suitable and the circumstances of the Circuit have not changed, it may on the application of the Circuit Meeting recommend a renewal of the authorisation for a second or third year, and the Authorisations Committee supports any such recommendation without further investigation (see lists B and C below). District Chairs should note that they need to advise the Authorisations Committee as soon as a probationer is recommended for ordination and therefore the Circuit no longer requires an authorisation.
- 9. The Committee draws attention to the provisions in SO 011(7) whereby in emergencies arising after the meeting of the Conference by the death of a presbyter or otherwise, the President,

- or the Vice-President on his or her behalf, may grant an authorisation having immediate effect and continuing until the 31 August following the next meeting of the Conference.
- 10. The Committee welcomes informal consultations with any Circuit considering making an application for an authorisation.
- 11. The Committee is grateful to all the Circuits and Districts for supplying this detailed information.
