- 1. The Authorisations Committee has reviewed applications from Circuits to authorise those who are not ordained presbyters to preside at services of Holy Communion. Careful consideration was given to applications using the established criteria.
- 2. The Committee considered a total of 106 new applications (including renewals after three years): 35 presbyteral probationers, 2 deacons and 69 lay people. One hundred and one authorisations are recommended without further qualification to the 2016 Conference. Two diaconal applications were recommended due to exceptional circumstances. The Committee declined to recommend one lay application on the basis that the Circuit should explore further the practice of Extended Communion. It declined to recommend one application for a presbyteral probationer as there were sufficient presbyters in the Circuit to preside at the required number of communion services. Further information was requested regarding three applications from one Circuit.
- 3. The Committee again had the opportunity to consider applications made under the missional criterion approved by the 2012 Conference. The Committee considered one application for a renewal made under this criterion, which was approved. The Committee will be requesting feedback from those Circuits granted authorisations under the missional criterion.
- 4. Application forms are available for the authorisation of probationer presbyters, deacons, lay persons, missional applications and renewals after the three-year term. These will be available to District Chairs in October. Applications need to be considered by Circuit Meetings, District Policy Committees and Synods before submission.
- 5. In the case of applications for authorisations for deacons, these should only be submitted following a thorough consultation with the Warden of the Methodist Diaconal Order and on the basis that the Circuit will make every effort to train a lay person to take up the role the following year. Future applications will be subject to the views of the Faith and Order Committee following the interim report on the Theology and Ecclesiology Underpinning the Diaconate (Agenda item 33).
- 6. All applications for consideration in 2017 should be submitted to the Conference Office by Thursday 6 April 2017. The Committee will meet at the end of April 2017 to consider the applications received.
- 7. Authorisations, when granted, are for one year and their scope is limited to the Circuit in which the person resides. If the District Policy Committee is satisfied that the person authorised remains suitable and the circumstances of the Circuit have not changed, it may on the application of the Circuit Meeting recommend a renewal of the authorisation for a second or third year, and the Authorisations Committee supports any such recommendation without further investigation (see lists B and C below).
- 8. The Committee draws attention to the provisions in SO 011(7) whereby in emergencies arising after the meeting of the Conference applications may be referred to the President, or the Vice-President on his or her behalf, who may grant an authorisation having immediate effect and continuing until 31 August following the next meeting of the Conference.

- 9. The Committee welcomes informal consultations with any Circuit considering making an application for an authorisation.
- 10. The Committee is grateful to all the Circuits and Districts for supplying this detailed information.

Review of the "Criteria for Authorising Persons other than Presbyters to Preside at the Lord's Supper" in light of Memorial M1 to the 2015 Conference

11. Memorial M1 to the 2015 Conference ("Authorisation to preside at communion") was as follows:

The South Bedfordshire (34/4) Circuit Meeting (Present: 61; Voting: unanimous) asks the Conference to amend the 'Criteria for Authorising Persons other than Presbyters to Preside at the Lord's Supper' (CPD 2014, Book VI, Part 3, p750). In paragraph 2, the Circuit Meeting would like the criteria for deprivation be changed from "if the answer is 13 or greater then deprivation is deemed to exist" to "if the answer is either 13 or greater, or, where it is requested, more than half of the Sunday services conducted by presbyters are communion services, then deprivation is deemed to exist".

12. The Conference adopted the following reply:

The Conference thanks the South Bedfordshire Circuit Meeting for its memorial. The ministry of Methodist presbyters is a ministry of word and sacrament, shared with the One Church of Christ and in which we rejoice. However, it is some time since the criteria for the current deprivation figure were set. It therefore directs the Connexional Authorisations Committee, with the Faith and Order Committee, to reconsider the criteria and to report to the 2016 Conference.

- 13. The review directed by the 2015 Conference was carried out by telephone conference between members of the Authorisations Committee and a representative of the Faith and Order Committee.
- 14. It was noted that in 2015, of the significant number of applications received for authorisations to preside, only two had a deprivation figure under thirteen (one of which was declined) and only two were based on missional criteria. The Committee was not aware of any factors in its work over the past few years that would show that change is needed. The memorial that led to this review does not mention a specific reason for asking for a change other than the number of communion services as a proportion of the total which presbyters lead; however, the criteria are already based "on the assumption that a full-time presbyter is able to conduct 26 Sunday services per quarter, half of which will be communion services." The Committee was particularly cautious on this issue; for presbyters the celebration of Holy Communion is a core aspect of the ministry of word and sacrament, so a suggestion that it might be desired that presbyters do this less often raises some significant issues about vocation. The Committee also noted that deprivation can also be addressed by other means through flexible patterns of worship.
- 15. Several of the points raised in this review seem to indicate that a broader discussion regarding authorisations (covering more than the criteria alone) may be timely and appropriate. This could take into account, for example, ecumenical considerations, and the training of those who are authorised. However, in response to M1, the Committee, in consultation with the Faith and Order Committee, saw no need to amend the criteria at this time.
